U.S. Class Actions: Impact on the Japanese Legal System

Case Study: the Google Book Settlement

The U.S. court settlement of October 2008 between The Authors Guild, Inc./The Association of American Publishers and Google Inc. concerning the on-line use of books (the "Google Settlement") is said to apply to non-U.S. residents, which greatly surprised interested parties in Japan.

The Google Settlement emerges at a time of intense discussions on class actions in Japan, initially triggered by the introduction of consumer organization litigations in 2006 and expectations regarding the role and activities of the new Consumer Agency established in September 2009.

By way of a case study, this Seminar will review the practical and theoretical issues that may arise if the effects of U.S. class actions were to extend to Japan, and try to assess possible implications on debates relating to the contemplated Japanese class action systems.

Through panel discussions, with the participation of persons directly involved in the Google Settlement, we will have the opportunity to listen to an in-depth analysis of the relevant legal issues, and to the views of lawyers from other jurisdictions on U.S. class actions and the long-arm reach of U.S. courts.
